The Mobile Homes (Requirement for Manager of Site to be Fit and Proper Person) (England) Regulations 2020

Register of fit and proper persons

This is Dacorum Borough Council's register of persons who the authority is satisfied are fit and proper to manage a relevant protected site (a licensed caravan or mobile home site) within its area.

The registration duty was introduced in July 2021, and from October 2021 it will be an offence for a protected site to be managed by a person who is not included on this register.
